

## GEAUGA PARK DISTRICT'S 2019 FAMILY FUN GIVEAWAY

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.**

1. **Promotion Description:** Geauga Park District's 2019 Family Fun Giveaway ("Giveaway") begins on Thursday, January 3, 2019, at 8:00 AM (EST) and ends on Monday, June 3, 2019, at 8:00 AM (EST) (the "Promotion Period"). By participating in the Giveaway, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Geauga Park District ("Sponsor"), which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Giveaway.

2. **Eligibility:** Open to residents of Geauga County, State of Ohio who are 18 years or older. Void where prohibited or restricted by law. Sponsor and its respective officers, directors and employees, and members of their immediate families and/or persons living in the same household as such persons, are ineligible to enter the Giveaway or win a prize.

3. **Entry:** No purchase required to enter or win. Entry may occur online or on an official paper form. To enter, entrants must complete and submit a brief survey collecting first and last name, address, phone number, email address and a choice of interests. Entrants submitting invalid or illegible email addresses will be disqualified. Submitting this survey automatically subscribes entrants to periodic email notices from Geauga Park District regarding updates and activities in the parks. To be eligible to win, entrants must remain subscribed for the length of the Promotion Period. Entry into any previous giveaway does not disqualify entrants from this giveaway, but a new survey must be completed and submitted in order to enter.

4. **Winner Selection:** The winner of the Giveaway will be selected in a random drawing from among all eligible entries received throughout the Promotion Period. The random drawing will be conducted the week of Monday, June 3, 2019, by Sponsor or its designated representative, whose decisions are final. Odds of winning will vary depending on the number of eligible entries received. Winner will be notified by phone after the random drawing. Potential winner must accept a prize as directed by Sponsor within 72 hours of notification. Any winner notification not responded to or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively "the Prize Claim Documents"). No substitution or transfer of a prize is permitted except by Sponsor in its sole discretion.

4. **Prizes:** – One (1) winner will receive a grand prize of camping gear of their choice from a vendor approved by Geauga Park District, plus two free camping reservations within Geauga Park District to be scheduled and used in 2019. Items purchased must be items used while camping, i.e. tent, sleeping bags, camping chairs, lantern, campfire cooking equipment, tree hammock, etc. Two runner-up winners will receive a quart of 2019 syrup made at Swine Creek Reservation as well as a selection of Geauga Park District promotional items. ARV of the grand prize is up to \$1,200. ARV of each runner-up prize is \$45. (The grand prize and runner-up prizes shall be collectively referred herein as “Prize.”) Prizes cannot be transferred, redeemed for cash or substituted by winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if the Prize is unavailable or cannot be awarded, in whole or in part, for any reason. Sponsor makes no representation or warranty concerning the appearance, safety or performance of the Prize awarded. Restrictions, conditions and limitations may apply. Each Winner is fully responsible for any and all applicable federal, state and local taxes associated with the Prize. Sponsor reserves the right to substitute any Prize (or any portion thereof) with a Prize of comparable or greater value at its sole discretion. Sponsor will not replace any lost or stolen Prize or Prize items. Failure to comply with the Official Rules will result in forfeiture of the Prize.

Sponsor’s database clock will be the official time keeper for this Giveaway.
