While on Geauga Park District property, every consideration will be given to protect Park property and resources from damage.

DISCLAIMER: The undersigned, a participant in Geauga Park District Wildlife Management Program, agrees that in consideration of Geauga Park District's permission to the undersigned to hunt and/or trap on properties owned or controlled by Geauga Park District to indemnify and hold harmless Geauga Park District from all cost, losses, damages, liabilities and expenses whatsoever which may arise from or be claimed against Geauga Park District by any person or persons for any injuries or damages to persons or property arising from activities of the undersigned participant when engaging in such Wildlife Management Program.

Furthermore, in consideration for such permission by Geauga Park District, the undersigned participant, for himself/herself, his/her heirs, executors, administrators, and assigns, agrees that he/she shall release and discharge said Geauga Park District, its officers, employees, agents, successors, and assigns, from all debt, claims, demands, damages, action, and causes of action that the participant may possess, or believe to possess, arising from his/her participation in said Program.

The undersigned further agrees to follow at all times Geauga Park District Rules and Regulations, the guidelines developed for the Program by Geauga Park District and the Division of Wildlife, and any applicable wildlife orders. The undersigned participant agrees that failure to do so may result in termination of the undersigned participant from the Program, at the sole discretion of Geauga Park District.
